- ❖ To promote and facilitate education and vocational training for women and children in Pakistan
- ❖ To reach out to those who lack basic human needs with the aim of restoring dignity and respect irrespective of caste, creed or gender.

This is a multi-faith grass roots Project supported by local groups in the UK. In response to community needs, Umeed Partnership Pakistan has established two schools and Education and Vocational Training Centres for women and children in communities situated in poorest areas of Pakistan where the literacy rate for women is amongst the lowest in the world. Centres have recently been established in slum districts in the tribal areas of Baluchistan, in Lahore slum districts and in the Cholistan Desert (Punjab Province).

Funds are needed to cover the running costs of the schools and Education Centres (situated in homesteads and community buildings) also training for the teachers who are women from within each community.
